Finally I have managed to attain those two things in my life now, I have a stable job that has offered me a bursary to study in the year 2019 until I complete my qualification and a study program to assist me work, manage and study at the same time.

I have unfortunately failed to meet the minimum pass score credits in the year 2018 due to my performance, adaptation & understanding of the UNISA system in the first semester and second semester due to lack of funds to re-register. I would like to appeal to the Chancellor of Engineering to please allow me the opportunity to continue with my studies in this year of 2019 - first semester.

I would also like to enquire/find out if I can continue in this course as I have been trying to attempt the course since 2014. 2016 – certificate in PPOM to reinstate my studies

2017 – Jan/Feb wrote exams for PPOM and passed it – received certificate late in the year

2018 – re-register 3 same modules – first semester passed 1/ failed 1/ sub 1 – second semester passed 1

2019 – blocked. Appealing for a reinstatement into the study faculty.


