

THE MANIFESTO OF THE UNISA LAW STUDENTS ASSOCIATION TSHWANE

We, the UNISA Law Students Association will be contesting the upcoming university SRC elections. Quite firmly, as a matter of fact, the SRC is a fundamental institution of voice capable of transforming the university business model and cater for the interests of the primary stakeholders, the students. We, therefore, intends to contribute largely to the promotion of quality and intellectual work of the university with motive to reimagine student's governance as a significant instrument of change. In addition, the basic core-thrust of this student-centred academic formation is to design programmes that will contribute to our tacit knowledge. Furthermore, the process of reimagining and rethinking the transformation process will require a programmatic, ideological, intellectual, and unquestionable political sagacity.

This text is a detailed plan of the commitments that will be ushered under the banner of an ULSA led SRC:

1. Decentralization of Critical Institution of Service:

Regional campuses are under-resourced. There is a systemic concentration of administration work in Tshwane. This is extremely problematic since regional campuses struggle to comprehend with students challenges and instead refer them to the main campus. ULSA, therefore, wishes to advocate for the decentralization of the administrative work to other regional campuses, this will assist to curb unnecessary migration of students to register in Tshwane. Regional campuses should have sub-faculty offices with lectures, libraries, clinics and so forth and the likes.

2. Curriculum Redesign and Transformation:

The UNISA curriculum is outdated. It appears that the university is fundamentally opposed to the emerging developments in society. A university curriculum should be inextricably intertwined with the developments of society. Consequently, there is a sense of scepticism in recruiting our graduates, particularly in the private sector. Our curriculum must be redesigned to suite the demands of the markets. Furthermore, our curriculum must remember the dismembered and distorted history of our forefathers. The curriculum should disengage from the western monochrome logic of western epistemology.

3. Student Funding:

ULSA is underpinned in the ideological fabric that intends to dismantle the traditional distribution of study funding. One of the principal objectives of our student formation is to advocate for a fair distribution of university funding. UNISA students are always

at the receiving end of punitive treatment and relegated to a substandard status. This unreasonable disrate and discriminatory funding model will be challenged in all strata of society, including the courts!

- PROMOTION OF COMPETITIVE SPORTS:**

The existing conceptual definition of the UNISA sports is extremely regrettably and lacks fundamental meanings. UNISA, to be precise, offers no competitive sports due to its character as a distance learning university. However, ULSA will advance its longstanding positionality of transforming the university to a dualistic intellectual landscape. Let it be optional to be distant from the campus and to be fulltime.
